Requirements for Modular or Mobile Homes

The following items are needed prior to submitting plans for building permit review.

- Two sets of building plans drawn to scale.
- Plans shall include at a minimum:
 - Name and address of the building
 - Door and window sizes
 - Stair and railing dimensions
 - Fire walls labeled (if required)
 - Electrical drawings with smoke detectors, GFCI and AFCI
- Copy of Camden County Planning and Zoning Permit (if applicable).
- One site plan showing where the building will be located on the property.
- If in a subdivision, a plot plan is required showing the location of fire hydrants.
- Provide all HUD documentation if purchased through HUD.
- All plans become public record once left in this office.

All inspections and plan reviews will be based on the following code books: 2006 International Residential Code, NEC 2005 Standards, NFPA Standards, Ordinances MCFPD 004, 007 and other updated material as relates to the proceeding and in the future.

Building permits shall be posted in site of operation until final inspection is complete. Post in front window upon installation of said item so as not to weather.

Electrical inspection is required for the service meter and electrical panel.

Final inspections shall be done before occupancy permit is issued. If the structure is occupied in any form without approval then a \$100 occupancy fine will be issued.

Permit is good for one year and must be renewed at the end of a year if not completed.

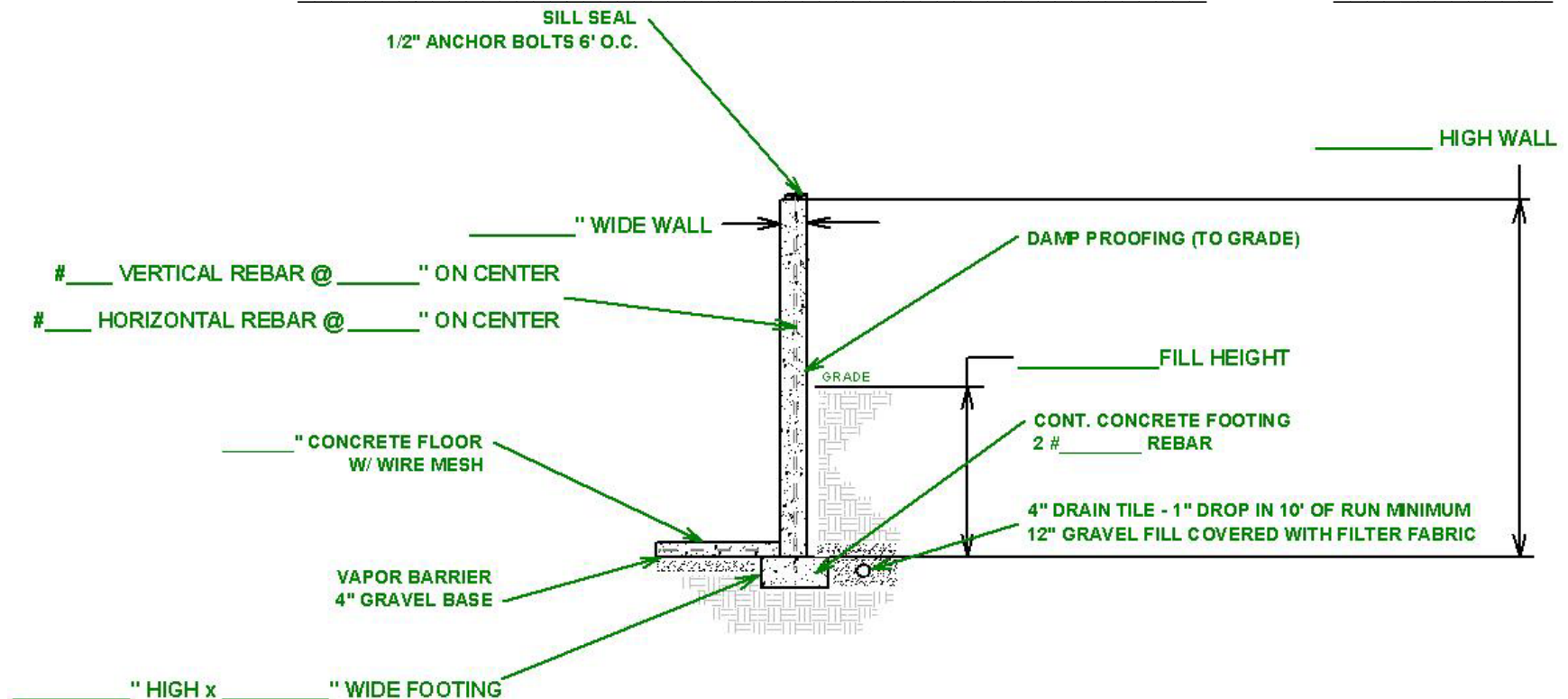
